

Panthers Westfund Half Time Game August 22, 2025 Terms and Conditions

WHO CAN ENTER?

- Entrants must be over 18 years of age at the date of entering the competition.
- Employees of Penrith District Rugby League Club (promoter), their immediate families or registered travel companions and any agencies associated with this competition are ineligible to enter.

HOW TO ENTER

- To enter the competition, you must submit an online entry by providing your first name, last name and reason why you would like to participate in the half time game, sent by email to marketing@westfund.com.au.
- The competition period commences at 00.01 AEDT on Thursday 14 August 2025 and ends at 5pm AEDT on Friday 17 August 2025.
- No late entries will be accepted.
- A limit of one entry to the competition per person applies.
- Entrants must be a member of Westfund Health Insurance.

SELECTION OF WINNER

- One (1) winner will be chosen based on the quality of responses which will take place on Monday 18 August by a Penrith District Rugby League Club representative or Westfund employee
- The winners will be notified by email .
