

## Terms and Conditions

### 2026 Panthers ticket Giveaway - Mouthguards

Information on how to enter and prizes form part of these Terms and Conditions and entry into this competition is deemed to be acceptance of these Terms and Conditions.

1. Entry is open to anyone who has had a mouthguard fitting at Westfund Dental Care Centre in Lithgow between 19 January 2026 and 27 February 2026. Westfund employees, and the immediate families of the Promoter, its associated companies, advertising agencies and participating retailers and their employees are ineligible to enter or win.

#### The Prize

5. Only 1 valid entry per mouthguard fitting. Entrants cannot win multiple passes unless multiple family members under the age of 18 have also completed a mouthguard fitting.
6. Entrants must be current patients of Westfund Dental Care.
7. For any patients under the age of 18 who have completed a mouthguard fitting, parent/guardian consent must be provided to go into the draw.
