

# Provider Recognition Criteria

To become or continue to be a recognised provider with Westfund, specific criteria must be met and adhered to. Westfund will only pay benefits in relation to treatments, health care goods and services where the member has that entitlement under their current policy.

Westfund Provider Recognition Criteria is set out under each service type, specifically recognising the Private Health Insurance (Accreditation) Rules.

Benefits are only payable for treatments, health care goods and services provided in Australia.

## What is a Recognised Provider?

A Recognised Provider means a provider recognised by Westfund for the purpose of paying Benefits. To become a Recognised Provider, the provider must be in Australia and among other things, satisfy the standards in the Private Health Insurance (Accreditation) Rules.

Recognised Providers include Hospitals, medical practitioners providing a Professional Service and providers of General Treatment that meet Westfund's Recognition Criteria.

Recognition Criteria in relation to Recognised Providers of General Treatment are:

- The provider is professionally qualified and belongs to a professional body recognised by Westfund;
- The provider is in independent private practice;
- The provider is registered or holds a licence under State or Territory legislation within Australia;
- Other recognition criteria determined by Westfund.

For the purpose of paying benefits, a health care provider can only provide treatment for the specialties their provider number is accredited for. A health care provider may be eligible to provide more than one kind of treatment as long as they meet the relevant standards applying to that treatment.

## Westfund's Provider of Choice Network

We are proud to have a strong network of dental and physiotherapy providers who work with us to help lower or eliminate out-of-pocket costs on selected treatments. Westfund Providers of Choice are also subject to the Provider Recognition Criteria applicable to their specialty.

## Provider Recognition Criteria for Providers:

### Treatments provided by allied health professionals (Medicare Registered Providers):

Providers must obtain a provider number from Medicare Australia who will notify Westfund of the provider number, provider details and all relevant practice information.

Allied Health Professionals as listed below must adhere to the following criteria to be a recognised provider:

- Must be Medicare registered and have a current Medicare provider number
- Have different provider numbers for each profession/provider type (e.g. physiotherapy);
- Provide treatments in private practice;
- Have a different provider number for each location of practice;
- Includes registration type (general/specialist) and specialist type (e.g. oral surgeon).

Treatments provided by an accredited ARHG (Australian Regional Health Group) provider:

Australian Regional Health Group (ARHG) accredit individual associations and the member of these associations for alternative therapy services as listed below.

On behalf of Westfund the ARHG ensure that our members have access to appropriately qualified providers of alternative therapy services.

- Providers must obtain a provider number from their affiliated association who will notify the ARHG. All ARHG registered providers are update weekly.
- Provider /Member Association numbers do not need to be location specific, association members are able to practice at other locations other than those nominated on the member details.
- Westfund will only accept full memberships where the provider has completed diploma qualifications or higher. Associate or student memberships are not eligible for the purpose of paying benefits.

Providers need to contact their association where not currently registered.

Members should read this in conjunction with their policy summary to understand the benefits payable under their policy.

Medical Service	<p>Registered as a Medical Practitioner with Medicare. Medical Practitioners include but are not limited to General Practitioners, Specialists, Radiologists, Pathologists and any other Medical Specialist as accredited by Medicare.</p> <p>Fees charged by medical practitioners while you are an inpatient are payable by Westfund, as long as a Medicare Benefit Schedule (MBS) item number applies to those services and a Medicare benefit is payable.</p> <p>Our Access Gap Scheme helps members with hospital cover to eliminate or reduce out-of-pocket expenses for medical gap payments. ### Audiology (Hearing) Tests, Hearing Aids & FM Systems

#### **Hearing Device Specialists and Hearing Aid Practices:**

Westfund's accreditation requirements for Hearing Device Specialists and Hearing Aid Practices include:

- Must be Health Fund registered, be in private practice and fulfil the Private Health Insurance accreditation rules
- Provider numbers are location specific
- Provider numbers for this category are allocated by Medibank Private (MP). MP will directly provide electronic claiming providers (HICAPs & IBA) with details of provider numbers and relevant practice information.

#### **Audiologist:**

An Audiologist must meet one of the following requirements:

- Allied Health Professional recognition criteria – Audiologist OR
- An Audiologist that holds a current Qualified Practitioner (“QP”) number for the Australian Government Hearing Services AND
  - Hold Full / Ordinary membership with the Australian College of Audiology (ACAud) with competency in hearing aid dispensing OR
  - Hold Full membership with Audiology Australia.

#### **Audiometrist:**

An Audiometrist must meet one of the following requirements:

- An Audiometrist that holds a current Qualified Practitioner (“QP”) number for the Australian Government Hearing Services AND
  - Hold Full / Ordinary membership with the Australian College of Audiology (ACAud) with competency in hearing aid dispensing OR
  - Hold Full membership with the Hearing Aid Audiometrist Society of Australia (HAASA).

#### **Otolaryngologist (ENT):**

An Otolaryngologist must meet the following requirements:

- Allied Health Professional recognition criteria - Otolaryngologist

Accounts/Receipts supplied by recognised providers must also to adhere to [Westfund's Receipt Validation Guideline](#). At Westfund's discretion, Westfund may:

- Grant recognition OR
- Refuse recognition OR
- Cancel a provider's recognition immediately or with notice dependent on the

circumstances of cancellation.
