



Panthers vs Raiders - Mudgee, August 1, 2026

Mascot Race Half Time Competition

1. These Terms and Conditions apply to the “Mascot Race Half Time Competition”
2. By participating, you agree to be bound by these Terms & Conditions.
3. The Competition is promoted by Westfund Limited ABN 55 002 080 864 of 59 Read Ave, Lithgow NSW 2790 (“Promoter” or “Westfund”).

The Competition

4. The Competition runs from 12:01am (AEST) July 10 to 5pm (AEST) Thursday 23 July 2026.(Offer period).
5. Up to six winners are selected.
6. This Competition is a game of skill.
7. Entry is free and no purchase is required to enter.
8. The Competition is open to Westfund members subject to these Terms and Conditions.

How to Enter

9. To enter the Competition, eligible entrants must click the link and complete the online form with name, age, address, email.
10. Limit of 1 entry per person, unless otherwise specified.
11. Incomplete, incorrect or fraudulent entries may be deemed invalid.

Prize Information

12. The prize consists of racing Claws, the Panthers mascot, at half-time on August 1, 2026 Glenn Willow Stadium Mudgee, at Panthers vs Raiders Game. The race winner will win a signed framed Panthers Jersey.
13. The total prize pool is worth \$1000.
14. Tickets for the game are not part of the prize; winners are responsible for their own entry/attendance for the match.
15. The prize is not transferable, exchangeable or redeemable for cash.
16. If any component of the prize is unavailable, the Promoter reserves the right to substitute the prize (or a part of the prize) with an alternative of equal or greater value.

Winner Selection and Notification

17. The competition will be conducted using random selection format.
18. The winner will be drawn at 5:15pm on Thursday 23 July 2026 at Westfund’s Head Office in Lithgow, NSW.
19. The winner does not need to be present at the draw to win.
20. The winner must be physically able to compete in the race against fellow competitors and Claws the Panthers mascot.
21. The first six valid entries drawn will be deemed the winners.
22. The winners will be notified by 5pm via email or phone Friday 24 July.
23. The winners must claim the prize within 1 day of notification.

35. Participants will need to complete a media and Penrith Panthers consent form to facilitate the photography/recording of the 'Race a Panther' event.
36. This draw is for the opportunity to participate in the mascot race at half time ONLY; tickets will not be provided to successful entrants.
37. Participants must be available to attend the Panthers vs Raiders game on 1 August 2026 at Mudgee NSW.
38. The Promoter's decision is final and no correspondence will be entered into.
